



MESSAGE FROM THE CEO

Happy New Year! Thank you very much for being a member of Fort Worth City Credit Union and for allowing us to serve your financial needs. Some of the new products and services we rolled out in 2023 were:

- New online real estate loan application portal. This may not seem like a big deal to most but it puts FWCCU on the highest level of providing an easy application portal for our members, as well as streamlining all backend processes and compliance reporting.
- Our new SMARTbuy auto purchase program is a lease-like program to help our members' ability to afford auto payments due to rising costs and interest rates.
- A new DriveFWCCU auto purchase program that is designed specifically for those that may have less than average credit. We understand things happen, so if you need a new ride, but your credit doesn't met the standard requirements, then this product is just for you.

As far as our growth and financial health is concerned, we had a decent year despite the headwinds of rapidly rising rates and inflation which slowed down loan and deposit growth. Here are a few highlights as of November month-end:

- Asset Growth = .03% This is driven by deposits; many banks and Credit Unions experienced some loss of deposits due to some investment rates rising in the external market.
- Loan growth = 7.68%
- Checking account growth = -1.32% We had to do a little clean-up of some dormant accounts this year.
- Member growth = 2.54%
- Net Worth = 11.25% Due to the meager growth in deposits, this increased nearly one percent from last year.

As highlighted in this newsletter, this year's profit-sharing numbers equal approximately \$592,000, which is about \$38 per member or 19% of net income. The details are as follows:

- Bonus Dividends = 30% (i.e., if you earned \$100 in dividends for the year, an additional \$30 was posted to your share account the evening of 12/31)
- Loan Interest Rebate = 3.5% (i.e., if you paid \$500 in interest on a loan this year, an additional \$17.50 was posted to your share account the evening of 12/31)

Borrowers received an interest rebate (refund) of 3.5% of the interest paid on all loans serviced by FWCCU, including credit cards. Interest rebates lower your effective interest rate and reduce your cost of borrowing from FWCCU.

Bonus dividends are a cornerstone of the not-for-profit model, and a benefit of doing business with Fort Worth City Credit Union. We've given back bonus dividends and interest rebates for over 30 years.

Please continue to refer your family, friends, neighbors, and coworkers to Fort Worth City Credit Union. Our growth and financial strength allows us to maintain an efficient and profitable operation, and as a result, we can continue to return earnings such as these to you.
